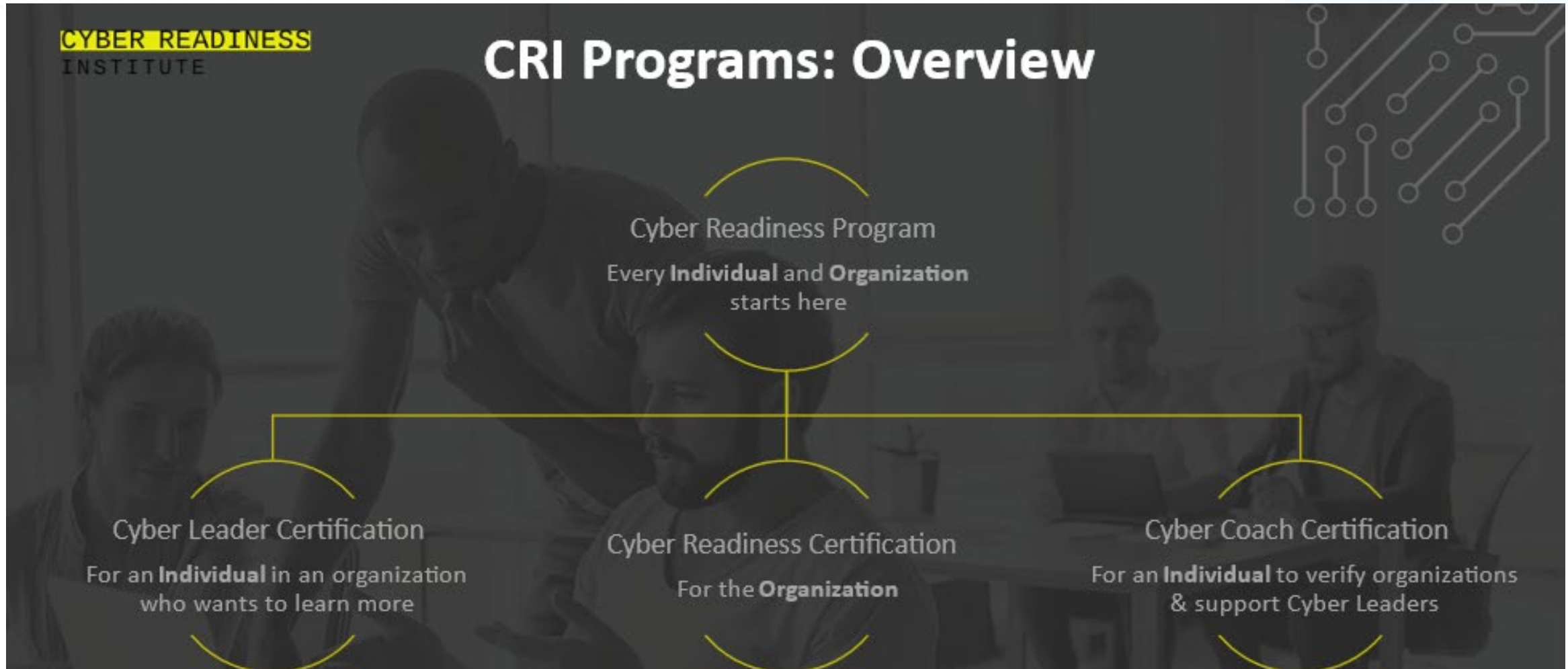

Case Study: Resiliency for Water Utilities

- Issue
 - Water Utility (WU) cyber vulnerabilities raise national security concerns around public health and safety
 - Policymakers searching for solutions
 - Water ISAC and the Water Sector Coordinating Council survey respondents identified “training and education” as their number one necessity
 - Challenges WU face:
 - Small organizations
 - Limited resources or technical capacity
 - Aging infrastructure
 - Legacy systems (Windows 7 or older)
 - Protocols and technology prone to cyberattacks

Case Study: Resiliency for Water Utilities

- Scope
 - Community Water Systems (CWS)
 - Supply Clean Water
 - Publicly Owned Treatment Works (POTW)
 - Manage Wastewater
 - Small WU (Services 501 to 3300 People)
 - Medium WU (Services 3301 to 10,000 People)

Case Study: Resiliency for Water Utilities

Phase One

- Launched in August 2023
- 50 Water Utilities Phase 1
- Supported by Certified CRI Coaches

Phase Two

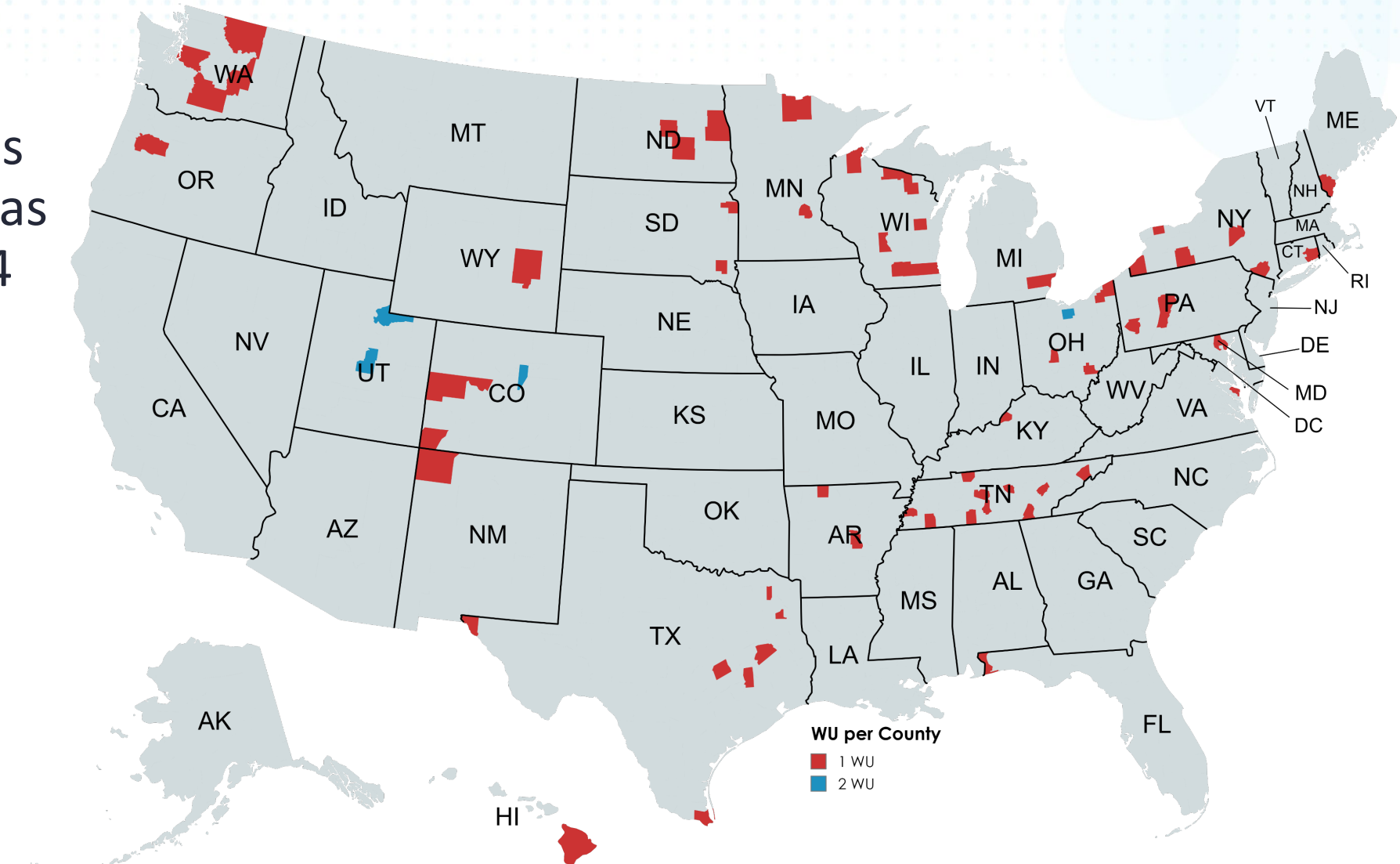
- If required, Secondary Course for SCADA Systems
- Additional 150 WU from across the United States

Collected data and feedback is analyzed across each phase to produce a final report.

- 76 Water Utilities express interest as of March 8, 2024
